

VIA ROVELLI UNATTENDED PARKING AREA - TOURIST BUSSES REGULATIONS

"Via Rovelli" Parking Area has been entrusted by Bergamo City Municipality to ATB Mobility S.p.A. as Manager.

The present Regulations discipline the terms and conditions of use of "via Rovelli" Parking Area to which each Customer must comply with. By accessing the Parking Area, the Customer acknowledges that he/she knows and accepts all the conditions and the shown rates, already approved by Bergamo City Minucipality, and signs a fixed-term contract with the Manager having as its object only the provision, respectively, use and occupancy, of a parking lot delimited by horizontal signs, in a Parking Area allocated for unattended parking.

The Manager's conditions are as follows:

- 1. According to what is compatible with the present Regulations, to the contract apply the Regulations of Legislative Decree 285 of 30.04.1982 and ss.mm.ii. Highway Code.
- 2. The Manager shall not be liable for damage of any kind suffered by the vehicles, or for theft, however occurred from whatever cause determined and/or damage caused to each other by users of the Parking Area or by third parties, or damage attributed to acts of vandalism. The Management also declines any liability for objects or luggage left in the vehicles.
- 3. Notwithstanding the provisions of the preceding paragraph, any damage to the vehicle, or theft and/or break-in of the same or theft of accessories, spare parts or individual parts of the vehicle however occurring within the Parking Area, shall be promptly reported to the present personnel appointed by the Manager.
- 4. The Customer is required to scrupulously observe the horizontal and vertical signage affixed in the Parking Area and to respect the delimitation of the stalls drawn on the road pavement. Circulation within the parking area is strictly at walking pace.
- 5. It is mandatory to leave the vehicle in the designated stalls with the engine off, perfectly braked and to take every precaution for the safety of their own property and that of third parties. The Manager is authorized to remove vehicles that are parked irregularly or constitute an obstruction with risks and expenses at charge of the Customer.

1 OPENING HOURS

Opening hours: 8:15 - 20:30

Entrance/exit after 8:30 p.m. must be requested in advance by mail (<u>rovellipark@atb.bergamo.it</u>) and authorized by the Manager. In case of emergency it is possible to call the number that will be provided by the present staff at the entrance of the Parking Area or, if necessary, the <u>unique number 112</u>.

After each call to the number provided by the Manager, the intervention time of the operator in charge of the opening/closing will be approximately 45 minutes.

2 FARES

The Parking Area provides the following fares:

- Half a day (4 hours): Euros 40
- Whole day (more than 4 hours): Euros 70
- Night **booking requested** (after 8.30 p.m.): Euros 40 till 12.15 p.m. of the following day

3 WAY OF PAYMENT

The vehicle may be picked up only after payment, to be made by Debit ore Credit Card, at the personnel appointed by the Manager.

4 ACCESSING THE PARKING AREA

To access the parking area, the Customer must slowly advance with the vehicle to the barrier and wait for the arrival of the personnel in charge who will authorize the access. The customer will be issued with a Parking Coupon to be shown at the exit to the present staff to make the payment. Parking is permitted in one of the stalls specially marked and/or specifically indicated by the present personnel.



5 EXITING THE PARKING AREA

Before moving the vehicle from the stall, the Customer must hand over the Parking Coupon delivered at the entrance and/or the reservation receipt to the staff in charge, who will quantify the amount based on the time of stay and handle the payment.

- The vehicle must always be picked up after the payment has been made.
- After the payment, the Customer is required, within 15 minutes, to leave the parking lot by going to the EXIT barrier while waiting for the barrier to open.

6 RESERVATIONS

Reservations must be made sending an email to rovellipark@atb.bergamo.it within ten working days before arrival with date, time of arrival and of departure.

In case of availability, a response from the Manager with details for making the payment will follow.

Payment, under penalty of cancellation of the reservation, is to be made within the next 3 working days by bank transfer, sending the transaction receipt to the above email.

Upon receipt of the credit will follow email confirmation of the reservation.

The reserved parking allows, within the relevant time slot already paid, to exit and re-enter the parking lot at no additional costs upon presentation of the reservation code to the operator present at the parking area. Outside the booked time slot, the rates indicated in point 2 will be applied.

7 PROHIBITIONS

It is forbidden to

- Carry out the Loading/Unloading of passengers within the Parking Area. Access to the Parking Area is permitted only to the driver of the vehicle and one possible partner. The Manager may use the appointed and specialized personnel for removal, also with the cooperation of the Police, of people found inside the parking area who do not prove to be users of the same.
- Stay or sleep inside parked vehicles.
- Use open flames and stoves or feed them with flammable, solid, liquid or gaseous substances.
- Leave within the vehicles flammable or explosive materials and/or substances, dangerous objects or whose
 presence may constitute a hazard.
- Unload or deposit objects of any kind, especially if flammable.
- Deposit outside the designated containers intended for collection any kind of waste.
- Carry out refueling and any maintenance or washing work of the vehicle, recharge batteries and accumulators in general.
- Stand for long periods of time with the vehicle running, warming it up and honk the horn.
- Park vehicles with leaking tanks or other defects likely to cause damage to the parking lot.
- Leave animals of any kind in parked vehicles.
- Park vehicles without regulatory or authorized replacement license plates.
- Park the vehicle outside the stalls drawn by road markings.
- Engage in behavior detrimental to order, safety, hygiene and decorum.
- Cause, in any way, disturbing noises by screaming and shouting, or by means of devices both sound and music.
